

POWER OF ATTORNEY

By this Power of Attorney "TaBBak" LLC represented by Trynkin N., General Manager, acting on the basis of the Articles of Association (hereinafter referred to as – "Copyright holder") authorizes:

"Internet Copyright Management" LLC, legal entity, incorporated under laws of the Russian Federation (INN 7704728247, PSRN 1097746339481, legal address 10 Arbat street, BC "Midland Plaza", Moscow, Russia 119002), (hereinafter referred to as – "Agent"),

to represent Copyright holder's interests before third parties in all government, non-government and international organizations, including in authorities of prosecutor's office, Ministry of Internal Affairs, Federal Security Service (Security Service of Ukraine), Inspectorate by Ministry of Taxation of Russia (National Tax Inspectorate of Ukraine), antimonopoly authorities, notariate's bodies, Mass Media (electronic Mass Media),

as well as other human rights bodies without territory limits on all issues, associated with the protection of exclusive property rights to audiovisual creation called: **«Yolki», creation: Russia (original Name «Novyy god shagaet po strane »), 2010.**

By this Power of Attorney Agent is empowered to:

represent Copyright holder's interests and perform acts on his behalf, aimed at protection of his intellectual property in world courts, courts of general jurisdiction, arbitration courts in all instances and proceedings stages, government and regulatory bodies, law-enforcement authorities, other organizations with all rights, legally conferred to claimant, recoverer, offended party, offended party's representative, including power to sign notice of claim and statement of defense, bringing it to court, application for interim relief, settlement of a dispute by arbitration, counter-claiming, full or partial withdrawal of claims, reduction of its amount, admission of claim, changing the subject and grounds of the claim, signing of petition for review of judicial acts on newly discovered facts, appeal of court judgements; right to all actions, connected with enforcement proceedings, including presentation and revocation administrative case, actions appeal of bailiff and executor of justice, without the right of adjudicated property and/or money receipt; participate in consideration of criminal cases with all rights conferred to offended party and civil claimant, including to testify, give evidences, present petitions and file objections, receive copies of orders on institution of criminal proceedings, on termination of criminal case, adjournment of criminal proceedings, as well as copies of High Court judgments, judgments of courts of appeal and cassational instances, make complaints against actions (omissions) and decisions of investigator, interrogation officer, public prosecutor and court, give explanations on brought action, waive lodged civic action fully or partially; participate in consideration of administrative violation cases, including familiarize with all case files, give evidences, present petitions and objections; perform other legal actions, which the Agent may consider necessary for ensuring rights and legal interests of the Copyright holder for protection of his intellectual property, including to conduct operations, aimed at identification of violation cases of exclusive copyright and associated rights of Copyright holder to audiovisual creations, take measures, intended to restraint of such violations, participate in research, investigations and examinations in any institutions, estimate property damage and amount of compensation for illegal use of Copyright holder's property rights, sign and forward letters, applications, make inquiries in all government institutions and authorities, certify document copies, receive correspondence on behalf of the Copyright holder.

The power of Attorney is issued till December 31, 2011 without the right of sub-delegation.
